Earlybirds Club Information 2023

Session Charges and Club Opening Times

Before school Standard fee charged at £5.00 per session 7.30am – 8.45am (includes breakfast)

After school Standard fee charged at £4.50 per hour

3.30pm - 5.30pm (There will be a penalty charge of £10.00 for every 15 mins late)

Payment of Fees

Your bill will be emailed a month in arrears on the last day of the month, payable by return. If your bill is outstanding after one week a £10 administration charge will be applied. If still outstanding after two weeks, your child's place will be withdrawn until the account is brought up to date. However, this may mean, at times, two months will be due for payment prior to school holidays.

Parents are required to book sessions one month in advance, during the last week of the current month.

Please also find attached a Parent Contract for you to read, sign and return, in acceptance of the Terms and Conditions.

Child Care Vouchers

Walmley Junior school will support all children by:



Earlybirds Parent Contract – September 2023

I hereby consent for my child to take up a place at 'Earlybirds' according to the terms and conditions set out below.

Vouchers should be activated as soon as you have received your email and should match amount outstanding on statement. Please do not activate vouchers for same amount each month. Payment must match the statement.

I will advise the Manager of any changes to the given information immediately and will inform them of any clubs that my child is due to attend.

I understand that no refund will be given for sickness days. Cancellation of pre-arranged bookings will require two weeks' notice for there to be no charge.

I give consent for a qualified First Aider to administer any medical treatment, which is urgently required.

I will inform the Manager of any holidays that are booked in term time (at least a month in advance).
