Before school Standard fee charged at £5.00 per session

7.30am – 8.45am (includes breakfast)

After school Standard fee charged at £4.50 per hour

3.30pm - 5.30pm (There will be a penalty charge of £10.00 for every 15

mins late)

Payment of Fees

Your bill will be emailed a month in arrears on the last day of the month, payable by return. If your bill is outstanding after one week a £10 administration charge will be applied. If still outstanding after two weeks, your child's place will be withdrawn until the account is brought up to date. However, this may mean, at times, two months will be due for payment prior to school holidays.

Parents are required to book sessions one month in advance, during the last week of the current month.

Child Care Vouchers
